By this License, TUVAl grants a You a limited, non-exclusive, non-transferable right to the personal use of the included Third-Party TTS Voice Software, subject to the following restrictions:

1. Permitted use shall not include the right to replicate, redistribute, broadcast or perform in public the sound files generated by the Third-Party TTS Voice Software Text-to-speech technologies with the Speech-Over product, except as linked to or embedded in the PowerPoint presentation from which they were generated or as converted with the presentation to flash or video.
2. Use in (1) shall not include the right to replicate, redistribute, broadcast or perform in public the sound files generated by the Acapela Text-to-speech technologies for commercial purposes. This specific type of use of Acapela TTS technology is subject to a separate licensing agreement.
3. It is not permitted to sell a narrated presentation which was produced by Speech-Over for profit.
